G.S.R.143 .-In exercise of the powers conferred by sub-section (2) of section 6 of the Rajasthan Transparency in Public Procurement Act, 2012 (Act No. 21 of 2012) read with rule 32 of the Rajasthan Transparency in public Procurement Rules, 2013, the State Government, being of the opinion that it is necessary for the socio-economic policies of the Central Government or the State Government, utilization of resources and expertise of the departments and enterprise of the Central Government or the State Government and saving the time, money and efforts of the procuring entities required in inviting and processing of bids individually, hereby makes the following amendment in this department's notification number F.1(8)/FD/GF&AR/2011 dated 04 September, 2013, as amended from time to time, namely:-

AMENDMENT

In table of the said notification, the existing serial number 57 and entries thereto shall be substituted by the following, namely:-

Goods and Services	The registered and approved start-ups, with QRate Score Bronze or higher with the State Government, may be given direct work orders without entering into the bidding process, as per the following criteria :- 1. QRate Bronze: Maximum Three Work Orders in a Financial Year per start-up 2. QRate Silver: Maximum Four Work Orders in a Financial Year per start-up 3. QRate Gold: Maximum Five Work Orders in a Financial Year per start-up 4. QRate Platinum: Maximum Six Work Orders in a Financial Year per start-up 5. QRate Signature: Maximum Six Work Orders in a Financial Year per start-up	1. The estimated value of the subject matter of procurement shall not be more than Rs. 25 lakhs (including taxes), and 2. Procurement shall be made from start-ups through only electronic platform provided by the Government of India or Government of
