G.S.R.115 .-In exercise of the powers conferred by sub-section (2) of section 6 of the Rajasthan Transparency in Public Procurement Act, 2012 (Act No. 21 of 2012) read with rule 32 of the Rajasthan Transparency in Public Procurement Rules, 2013, the State Government, being of the opinion that it is necessary for the socio-economic policies of the Central Government and the State Government, utilization of resources and expertise of the departments and enterprises of the Central Government or the State Government and saving the time, money and efforts of the procuring entities required in inviting and processing bids individually hereby makes the following amendment in this department's notification number F.1(8)/FD/ GF&AR /2011 dated 04 September 2013, as amended from time to time, namely:-

AMENDMENT

In column 2 against serial number 59 of table of the said notification, after the existing item (b) and entries thereto in column (3) and (4), the following the new item (c) and entries thereto in column (3) and (4) shall be added, namely.-

(c) Construction, Operation and Maintenance work of Toilets in Government Buildings	Sulabh International Social Service Organization	1. The estimate for toilets in Government buildings shall be prepared as per respective BSR and the rates shall be decided as per specifications of the work by the following, committee:- (i) Secretary, In charge, Administrative Department- Chairperson (ii) Head of the Department concerned- Member (iii) Representative of the Finance Department not below the rank of Joint Secretary- Member (iv) Engineer, not below the rank of Superintending Engineer of concerned Department (if available), if not available then Engineer, not below the rank of Superintending Engineer of Public Works Department/Department of Local Bodies- Member (v) Senior Most Accounts Officer of the Department

The following Committee is to ensure and monitor the maintenance, cleanliness and to decide maintenance charges for the existing toilets :-</p> <p>(i) Head of the Department- Chairperson (ii) Head of the office of the Procuring Entity- Member (iii) Engineer, not below the rank of Superintending Engineer of concerned Department (if available), if not available then Engineer, not below the rank of Superintending Engineer of Public Works Department/Department of Local Bodies- Member (iv) Senior Most Accounts Officer of the Department concerned- Member Secretary</p> <p>3. The Sulabh International Social Service Organization, hereinafter referred to as the organization, will be paid 10% of supervision charges in addition to the estimated cost of specified construction work.</p> <p>4. The date of commencement of construction shall be calculated from the date of issuance of work order. If the organization fails to complete the allocated work within the period stipulated for completion, the department shall suitably increase the period of completion after imposing liquidated damages as per rules, which shall not exceed 10% of the delayed construction cost.</p> <p>5. The maintenance, repair and sanitation work of toilets shall be done by the organization for 10 years. The maintenance charges shall be payable to the Organization by the Procuring Entity.</p> <p>6. The concerned Department shall execute a contract in this regard with the Organization.</p> <p>7. In case of any dispute arising out of the conditions of the contract, the decision of Government shall be final.</p>
